

## **STATEMENT OF COOPERATION**

We are aware of the basic philosophy upon which Ross Corners Christian Academy exists. This Academy is a third arm to families who enjoy a vital relationship with God and permit that relationship to dominate the atmosphere of their homes. We accept the Academy's readiness to join the Christian home and the Christian church in training Christian children for citizenship in two worlds. Because the Academy was originated for the purpose of educating the children of Christian parents in a biblical manner, we count it a privilege to attend and will, by God's grace and help, support the purposes and teachings of the Academy and uphold all rules in the RCCA Student-Parent Handbook, even though we might not understand or agree with it all. We recognize our responsibility to read the handbook and to attend mandated parent orientation meetings to become knowledgeable of RCCA's rules and standards. Believing that discipline is essential for the welfare of the students and the school, we agree that teachers be given the liberty of making and enforcing classroom regulations in accordance with Biblical principles. Understanding that attendance at the Academy is a privilege and not a right; we acknowledge the Academy's prerogative to dismiss any student who does not cooperate with the educational process or who violates any of the rules and standards established.

## **STATEMENT OF STUDENT COOPERATION**

*Please read the following statements carefully and sign below to indicate your agreement.*

1. I appreciate the social and spiritual standards of RCCA and will not tolerate or use profanity, obscenity in word or action, dishonor the Word of God, or show disrespect to the teachers/staff or property of RCCA.
2. I agree that, while a student at RCCA, I will refrain from immorality, the use of tobacco, alcohol, vapes, pornography, harmful and illegal drugs at all times both on and off the campus.
3. I agree that, while a student at RCCA, I will not possess, transport or harbor on the campus any of the following: weapons (including but not limited to guns, knives, lighters, etc.), drugs, alcohol, vapes, pornography, or anything else that is detrimental to the mission of RCCA.
4. I agree that while a student at RCCA, I will not access, view, download, display, transmit, create, otherwise possess or disseminate any online material that contains pornography, obscenity, or sexually explicit, pervasively lewd and vulgar, indecent or inappropriate language, text, sounds or visual depictions.
5. I agree that while a student at RCCA, I will not utilize any technology to harass, demean, humiliate, intimidate, embarrass, or annoy other persons both on or off the campus. I understand that any cyber-bullying type behavior, on or off-campus, that is determined to substantially disrupt the safety and/or well-being of the school community may result in disciplinary action by the academy.
6. I agree to support and abide by all regulations of RCCA as outlined in written (handbook or handouts) or oral form. This includes the RCCA Statement of Belief.
7. I have read and agree to abide by the RCCA Student Dress Code.
8. I realize that discipline, suspensions, or expulsion from school may result from my refusal to comply with such regulations.
9. I appreciate that the faculty and administrators of RCCA will care for me, will pray for me, and will work with me to help me develop my God-given gifts and abilities for His glory and for my benefit and that of others.

## **STATEMENT OF PARENTAL COOPERATION**

*Please read the following statements carefully and sign below to indicate your agreement.*

1. I agree to uphold and support the educational standards of Ross Corners Christian Academy (RCCA) by providing a place at home for my child to study and give my encouragement, and help as I am able, in the completion of any homework or assignments.
2. I support the RCCA Statement of Belief, and the moral and spiritual standards of the school and will not tolerate profanity, obscenity in word or action, dishonor to the Word of God, or disrespect to the personnel of the academy and fellow students. I hereby agree to support all regulations of RCCA and authorize the academy, in keeping with stated policies, to employ such discipline as it deems wise and expedient for the training of my child.
3. I agree that while registered at RCCA my child will refrain from immorality, the use of tobacco, vapes, alcoholic beverages, pornography, and harmful, illegal, or controlled substances at all times, both on and off campus.
4. I agree to pay my financial obligations to the academy by the due dates. I realize that accounts 30 days past due may be subject to a late payment fee if no arrangement has been made regarding a hardship situation. I also understand that if my account become 90 days past due, then my student may be subject to dismissal for lack of payment, and student records may not be sent until payment is received in full.
5. I understand RCCA reserves the right to dismiss any child (1) who fails to comply with established school regulations as outlined in written (handbook or handouts) and oral form, (2) who has severe behavioral problems, or (3) whose parents' or guardian's financial obligations remain unpaid.
6. I agree to release and hold harmless RC Christian Academy, Inc., its agents and employees from all claims, damages, or other liabilities to the student which are not the result of gross negligence by RCCA, its agents, or employees. Further, I absolve the academy from liability due to any injury to my child at RCCA or during an away from school activity.
7. The Parent agrees to indemnify RCCA for any damage or destruction done by the student to the buildings, equipment, books, or any other property owned by or in possession of RCCA.
8. I understand that the RCCA handbook does not contractually bind RCCA and is subject to change without notice by decision of the RCCA school board and administration.
9. I understand that admission to the academy is a privilege, not a right, and admission for one school year does not guarantee admission for future years.
