PAYMENT POLICIES

- All tuition payments must be collected by FACTS Management Tuition.
- FACTS Tuition payments are paid by ACH (monthly debit from bank Credit/Debit card (adding 4% charge).
- FACTS Tuition payments may be made on the 5th or 20th of each month.
- FACTS Management "Insufficient Funds" fee charged by FACTS: \$20
- Aftercare, unpaid Textbook and Sports Fees and delinquent lunch account balances will be automatically charged to monthly FACTS account.
- All RCCA accounts must be paid in full prior to the start of the next school year before official records (including transcripts) are released to another education institution, or re-enrollment at RCCA.
- Students withdrawing from school during the school year must pay a withdraw fee of \$400 (per student) and have their tuition for the school year based on a 10-month scale (Sept-June), with the month in progress counted as a full month owed, regardless of their initial monthly FACTS account setup.
- Rates are not affected by child's illness, school closings, holidays, vacation or snow days.
